






#### **OVESCO Limited IPS & OSSS** Generation Last 12 months




## **Cumulative project performance**

## Technical challenges we have resolved in 2024

- Wallands Primary School had a leaking flat roof, we removed 40% of the PV system so that ESCC could bring in a contractor to repair the flat felt roof.
   We expect to have the removed PV panels back on the roof early November.
- Priory School we monitored the PV system and found it was degrading, so we
  took the decision to replace the entire system. The new system is working as
  expected and we are very pleased with its performance. There was no cost to the
  school for replacing the PV system.

The Ouse Valley Climate Action Project & other funded work

- Eco Extravaganza Lewes Town Hall over 250 attended
- **Eco Open House** over 20 properties and over 650 visitors



- 6 paid part time Energy Champions so far since April given advice to over 800 people in the Lewes District
- At end of second year of funding from OVCA (three-year project)
- Secured funding from **DESNZ** for energy advice
- Secured funding from UK Power Networks for energy advice
- Set up GetBikery CIC which now has eCargo bikes operating in Lewes and Newhaven
- Supported several educational events including STEM and pupil work experience


## **Projects in Development**


